As the designated fundraising entity for EPCH, the Foundation raises funds for EPCH and Childrens Miracle Network (CMN) through grants, major gifts, events and annual fund drives with a focus on strategic areas of care that enhance the health and well-being of children throughout the region and expand the availability of quality care for all.
